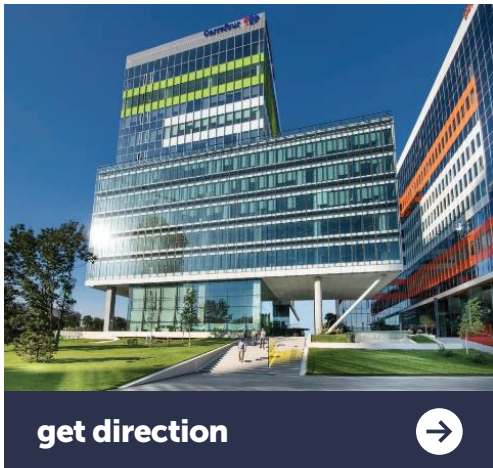

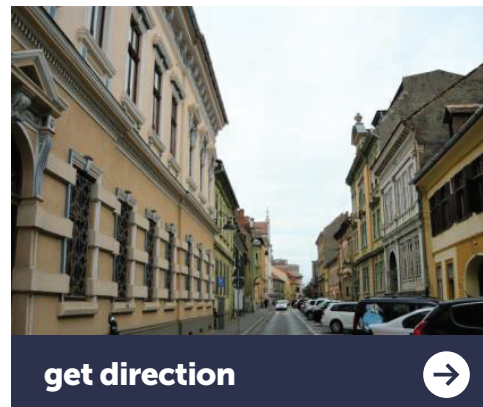

TAX TECHNOLOGY SERVICES

SAF-T Submission Deadlines

- **July 2022:** Deadline for the submission of the D406 declaration for the months of January 2022 through June 2022 by **large taxpayers**.
- **January 2023:** **Mid-sized taxpayers** will have to start submitting the D406 reports on a monthly basis.
- **January 2025:** **Small-sized taxpayers** and **non-resident companies** will have to start submitting the D406 reports on a monthly basis.

e-Invoicing Submission Deadlines

- **July 2022:** Deadline for submissions through e-Factura for companies dealing with what the Romanian Fiscal Administration considers to be **high fiscal risk products**: fruits and vegetables, beverages (incl. alcoholic), footwear and specific types of raw materials and clothing (incl. clothing accessories).
- **2023:** Submission of invoices electronically through the e-Factura system will become mandatory for **all companies** offering any product or service.

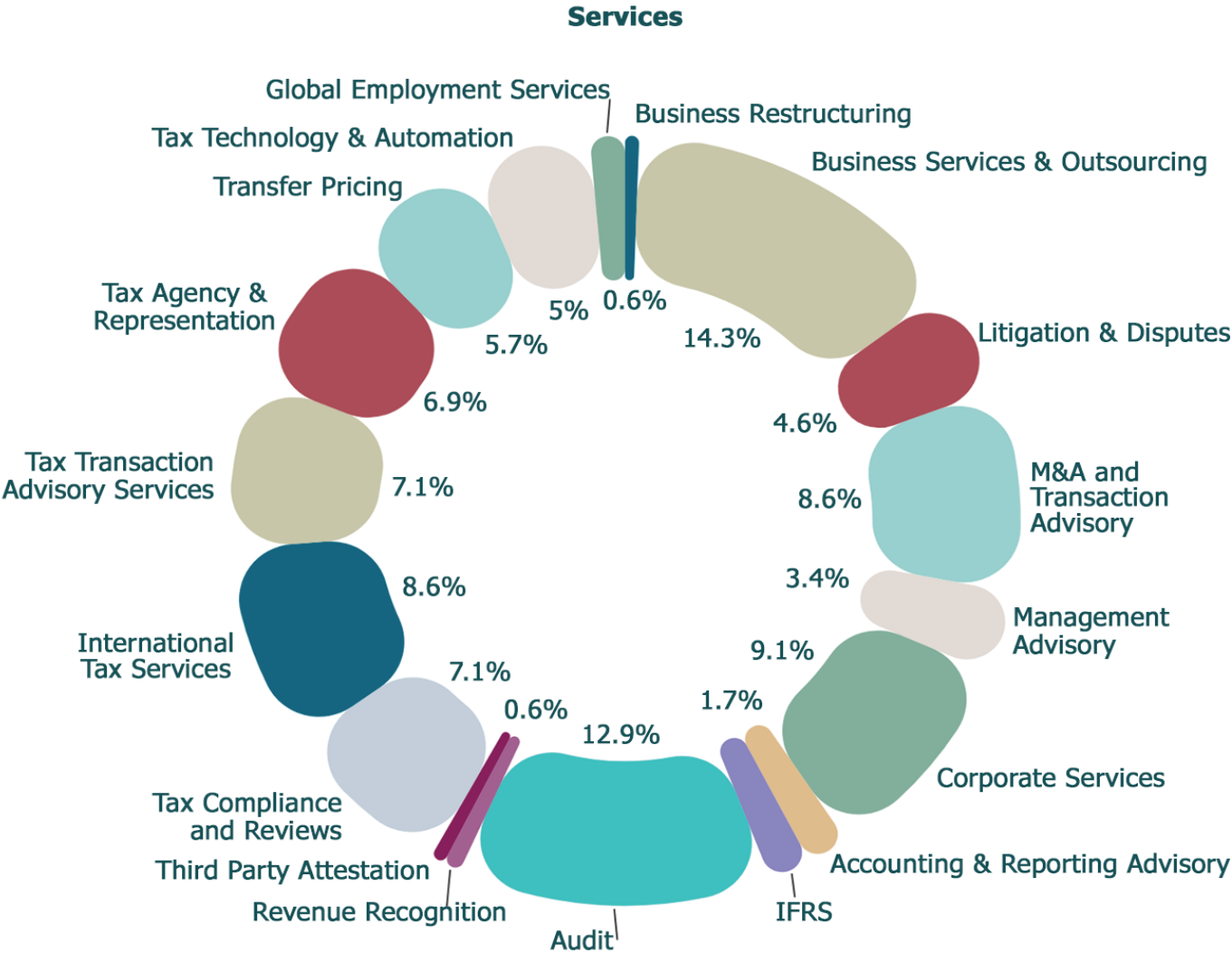
